## 2018 MATERIAL REQUIREMENTS

All ads must be in a DIGITAL format. Failure to adhere to these specifications may result in the ad materials being returned for revisions.

Acceptable software includes

+ Adobe Indesign CS5 versions 7 or less
+ Adobe Illustrator CS5 versions 15 or less
+ Adobe Photoshop CS5 versions 12 or less
Additional files include
+ .pdf - high resolution/press quality only
+ .eps - flattened files only
+ .tif - flattened or layered files 300 dpi minimum at actual size
+ .jpg - high resolution 300 dpi minimum at actual size

Acceptable color profiles and resolution

- Images must be in a CMYK color mode
+ Images must have a resolution of 300 pixels per inch (300 ppi or 300 dpi )
+ All colors used in a document must be defined as CMYK process colors
+ Spot colors must be converted to CMYK
+ Web images or images taken from websites are not acceptable (due to low resolution with $72 \mathrm{dpi})$
